















A MESSAGE FROM THE ARTISTIC DIRECTOR

"Best Pandemic Pivot: Children's Theatre of Charlotte" - Queen City Nerve

Last season will forever be marked by the onset of COVID-19 and the need for the performing arts to "pivot" their programming in order to continue to support the community. Children's Theatre earned the title of the "Best Pandemic Pivot" from the Queen City Nerve. Our 2019-20 season was a tale of two worlds: pre-pandemic and post-pandemic.

We opened our pre-pandemic season with the Broadway classic *Peter Pan*. We brought in a long-time favorite director, Jenny Male, who is both a certified fight choreographer and as well as intimacy director, to helm this piece. In a world that is re-imagining what it means to be equitable, inclusive and kind, we were excited to use this as an opportunity to both bring this classic to life while re-examining the impact of stereotypes on young people. For a hundred years this classic story has included a piece that at its core, many deem racist: Tiger Lily and her "Indian" tribe and the song they sing. In our re-imagined script this storyline was re-framed as the story of a fictitious and mythical Tiger Lily and her band of fierce female warriors called the Pounce.

Our third installment of The Kindness Project was a sleeper hit as it was based on a book that third graders across the region were reading. A musical adaptation of the award-winning picture book, *The Invisible Boy*, written by Trudy Ludwig and illustrated by Patrice Barton, made its way to the Wells Fargo Playhouse stage. The stage play was written by long-time Children's Theatre collaborator, Christopher Parks. We brought the creators of the book to Charlotte in order to interact with young audience members and to be part of the Charlotte Mecklenburg Library's EpicFest.

Tony-winning director, and Charlotte's very own, Corey Mitchell, lead the creative team as director of our next piece, Akeelah and the Bee. It was the third piece of the season that allowed our School of Theatre Training students to work alongside professional actors on our stage. It also brought back one of our favorite scenic designers, Anita Tripathi.

Our final pre-pandemic show of the season was another collaboration and co-production between Children's Theatre and The Experiential Theatre. Christopher Parks collaborated with local hip-hop artists and actors, Rahsheem Shabazz and Ron Lee McGill, to create

a fresh new musical called *GRIMMZ Fairy Tales*. Children's Theatre also partnered with Charlotte Mecklenburg Schools and their E3 program to bring 5th graders to this show.

Unfortunately, on March 10th, 2020, we were forced to close *GRIMMZ Fairy Tales* as well as our doors for the next several months. We shut down the tour of our Resident Touring Company, our preschool show, *Balloonacy*, our teen show, *Afflicted Daughter's* of *Salem*, and one of our biggest shows of the year, *Dragon's Love Tacos*.

We had just finished our School of Theatre Training program and those students were about to embark on one of the most exciting programs at Children's Theatre, OnStage. As we looked around the region, all schools were closing, and all the performing arts were shut down. While we did not know what the future may present, and we were sheltering in place as a community, we continued to want to be of service to our young students. We decided to continue our OnStage program virtually. We also decided to immediately offer free streaming for two of our past recorded productions. To provide a richer experience, we also virtually gathered writers, designers, directors and actors to provide live context and deep conversation about the creative process. Our award-winning education team also pivoted with our summer programming and immediately began creating online curriculum for June Summer Camps.

As we move into the unknown of the new season, your unwavering support has been incredible and valued. Children's Theatre continues to be of service to the community and your support and partnership is vital. As we serve our audiences, students, schools and community partners, your involvement as partner, donor and friend is necessary and allows us to move forward with our mission to "create exceptional theatre experiences, inspiring generations to explore the wonder of their world."
